Course features:

- The CPL with Multi Engine Instrument Rating course is suitable for anyone wishing to pursue a career as an Airline Pilot, Corporate pilot or any other position requiring operation of aircraft under Instrument Flight Rules (IFR)
- This course provides the minimum qualifications normally required for Airline entry.
- In the PPL/CPL components of the course you will learn to fly single engine aircraft under Visual Flight Rules (VFR). You will then progress to learn to fly twin engine aircraft and to utilise the aircraft instruments and procedures to fly by Instrument Flight Rules (IFR)
- Upon successful completion of the CPL Flight Test and then your Multi Engine Instrument Rating flight test, you will be issued a CPL with Multi Engine Instrument Rating by the Australian Civil Aviation Safety Authority. This Licence/Rating meets ICAO (International Civil Aviation Organisation) standards and can be easily converted in most countries. Contact your local Civil Aviation Authority for local conversion requirements.
- Your CPL with Multi Engine Instrument Rating will provide you with most of the credits you need to be issued a Diploma of Aviation. If you are interested in a Diploma, please contact us for details.

COURSE ENTRY REQUIREMENTS

- **Aviation Medical**
Pass an Australian Civil Aviation Safety Authority (CASA) Aviation Medical. To practice as a Commercial Pilot you need a Class 1 Aviation Medical. Therefore you MUST be either pass this medical or be capable of passing it. In order to sit the CPL exam, a Class 2 Aviation Medical is all that is required. As a Class 2 medical is easier and cheaper than a Class 1, you may choose this option however we recommend a Class 1 so that you are sure that there are no unforeseen problems preventing you flying commercially.
- **Age**
Be 18 Years of Age by course commencement
- **Education**
 - Have **minimum** qualifications or experience to the equivalent of the completion of Australian Year 10 (the 4th Year of Secondary School)
- **Police Check**
 - Be willing to undergo a Federal Police check in Australia for issue of your ASIC (Aviation Security Identity Card)
- * **English Proficiency**
The English Language requirement that applies to you depends upon your "Country Assessment Level".
To ascertain which "Country Assessment" level applies to you visit: <http://www.immi.gov.au/allforms/pdf/assessment-levels.pdf> (Note: our courses come under Visa Sub Class 575 NON AWARD) If you don't have access to this document, contact us and we will advise you of your Assessment Level
 - A) **If you are from an Assessment Level 3, 4 or 5 country** (as per Department of Immigration guidelines) you MUST undertake an IELTS test and score a minimum overall test score of 5.5 (with no test score less than 5.0). Either the "General" or "Academic" IELTS tests are acceptable.

B) If you are from an Assessment Level 1 or 2 Country, the following English Language requirements apply to you:

In accordance with CASA regulations we need to be satisfied that you meet one of the specified criteria listed below, by showing us a suitable document that gives evidence that you have met one of the following requirements:

i. The applicant has undertaken or completed his/her secondary education in an Australian or New Zealand educational institution, or the equivalent of an Australian secondary education in a country where one of the principal mediums of instruction had been in English

*Therefore, if you **completed** Secondary School (and can provide us with a copy of your High School Certificate) AND if your school used English as one of the principal mediums of instruction (at least 50% of instruction in English) AND you can provide a letter from the school confirming this, you meet the requirement.*

The applicant is still receiving secondary education in Australia or New Zealand where the language of instruction at the school is English.

OR

ii. The applicant has spent at least three in the past five years of employment in Australia, New Zealand or a specified country (UK, USA, Republic of Ireland, Canada*), where the documented evidence may include a group certificate, a number of pay slips or a letter from your employer stating the period that you worked in that workplace

* For Canada, proof of English language proficiency may still be required

OR

iii. The applicant meets or exceeds one of the following minimum test scores:

a. IELTS (International English Language Testing System) Overall minimum test score 5.5 with no band less than 5.0 (Test Bands include Listening, Speaking, Reading & Writing)

b. TOEFL (Test of English as a foreign language) Paper based minimum test score 530

c. TOEFL Internet based minimum test score 71

d. TOEFL Computer based minimum test score 197

e. TOEIC (Test of English for International Communication) Minimum test scores: Listening 350. Reading 300.

Speaking: 160. Writing 140

Note: If you do not meet our English requirements for direct course entry, you have the option of undertaking a preliminary English course with our associate English College in Melbourne. If you would like to take up this option, please notify us and we will send information to you.

Note:

i) When you train for a CPL, you will conduct your PPL as a preliminary step. This is included as part of this package and is included in the fee of AUD \$72,011

ii) The course fee does not include:

- Theory exam fees. These are payable by the student directly to CASA. Allow a budget of approximately AUD\$1200
- Course Application fee of AUD\$1500
- Licence issue fees for the PPL, CPL and IR. Allow approximately AUD\$300
- Landing fees & Air Services charges. Allow a budget of approximately AUD\$2000-2500
- Application for your Student Pilot Licence Approximately AUD\$50
- Application for your Security Clearance/Police check (known as ASIC) Approximately AUD\$200
- Aviation medical. Allow a budget of \$200-\$600 depending on where the test is conducted and whether you are conducting a Class 1 or Class 2 medical.

iii) The course includes the flying hours outlined herein. Should the student require additional training or have to re-sit any exam or flight test, the additional cost will be charged at current published rates
